I am either (i) the participant or (ii) the parent or legal guardian of the participant(s) who will use the inflatable equipment and/or other rental items supplied by the Company at the Event (the "Rental Equipment").

If any participant is under eighteen (18) years of age, I represent and warrant that I am the parent or legal guardian of the minor participant(s) and that I have full authority to sign this Waiver on their behalf. I agree that this Waiver is binding on me individually and, to the fullest extent permitted by law, on the minor participant(s), and on our respective heirs, assigns, and legal representatives.

1. Voluntary Participation & Assumption of Risk

I understand that the use of inflatable bounce houses, slides, obstacle courses and related equipment, including blowers, extension cords, anchoring devices, stakes/sandbags, mats and other accessories (collectively, the "Rental Equipment"), involves inherent risks that cannot be eliminated even with care and safety rules. These risks include, without limitation: falls; collisions; impacts with walls, entrances/exits, or other participants; flipping or rough play; entanglement; improper use; sudden deflation due to power loss; equipment malfunction or failure; shifting, tipping, or movement of the Rental Equipment; hazards created by anchoring points; uneven, wet, or slippery surfaces; and acts or omissions of other participants or spectators. I voluntarily choose to participate (and/or allow the minor participant(s) to participate) and assume all such risks, including the risk of serious injury, illness, property damage, or death.

2. Release of Liability & Indemnification

To the fullest extent permitted by law, I hereby release, waive, discharge and covenant not to sue the Company, its owners, employees, agents, contractors and insurers from any and all claims arising out of or related to the Event, including claims of negligence. I further agree to defend, indemnify and hold the Company harmless from any claim, damage, loss or expense (including attorneys' fees) brought by or on behalf of any participant or third party.

3. Participant Supervision & Safety Rules

I agree that a competent adult (18 years or older) will actively supervise the Rental Equipment at all times and will enforce all safety rules provided by the Company and/or posted at the Event. At a minimum, I agree to ensure: (a) participants remove shoes, eyewear, jewelry, and sharp objects; (b) no food, drink, gum, or candy is permitted on or near the Rental Equipment; (c) no flips, wrestling, piling-on, climbing on walls/netting, or other unsafe behavior is permitted; (d) height/weight limits and maximum occupancy are enforced; (e) the entrance/exit is kept clear; (f) participants of significantly different sizes are separated when necessary; and (g) participants exit immediately upon instruction or if any unsafe condition occurs. I also agree not to move, disconnect, tamper with, or alter the Rental Equipment, blowers, cords, anchoring devices, stakes, straps, or tie-downs.

4. Minor Participants & Guardian Acknowledgment

For any minor participant(s), I consent to their participation and certify that I am legally responsible for them. I understand that inflatables require continuous supervision and strict rule enforcement. I agree to supervise the minor

participant(s) (or ensure another competent adult does so) and to prevent participation by anyone who is intoxicated, ill, injured, or otherwise unable to safely participate. I accept full responsibility for the actions and conduct of the minor participant(s) at the Event.

5. Medical Treatment Authorization

In the event of an injury, I authorize the Company and emergency personnel to secure medical treatment deemed necessary, and I agree to be financially responsible for such treatment.

6. Weather / Electricity / Site Conditions Disclaimer

I acknowledge that inflatables must be shut down and cleared immediately during hazardous conditions, including but not limited to high winds (including sustained or gust winds that make operation unsafe), rain, lightning, or severe weather. I further acknowledge that continuous, dedicated electrical power is required to operate the Rental Equipment and that a power interruption may cause deflation and require immediate evacuation. I agree that the Company may require shutdown for safety at any time. Loss of power, weather-related shutdown, or other safety interruptions do not relieve me of payment obligations to the fullest extent permitted by law.

7. Photo / Video Consent (Optional)

Optional: The Company may photograph or video the Rental Equipment and/or participants during the Event for legitimate business purposes, including marketing. If I grant consent, I authorize the Company to use such images/recordings without compensation. If I do not wish to grant consent, I will leave the line below blank.

8. Severability & Governing Law

If any portion of this Waiver is held invalid, the remaining provisions shall remain in full force. This agreement is governed by the laws of the state in which the Event is held.

9. Entire Agreement

This Waiver constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes any prior or contemporaneous understandings or representations. No modification of this Waiver is binding unless in writing and signed by the Company and the undersigned.

10. Acknowledgement of Understanding

I have read this Waiver & Release of Liability and fully understand its terms. I understand that I am giving up substantial rights, including the right to sue. I sign this document freely and voluntarily. If signing as a parent or legal guardian, I certify that I have authority to sign on behalf of the minor participant(s).
